EXPLANATION OF THE DEED OF GIFT TO THE LOCAL HISTORY COLLECTION

The Deed of Gift form is designed to legally assign to The Yorba Linda Public Library the materials that you as a Donor are conveying to the Local History Collection to be administered in accordance with its established guidelines. The Deed of Gift form constitutes the transfer of title and serves to define the terms of the transfer.

All Donors of material to the Local History Collection are asked to sign a deed of gift form, and are given a copy of the signed form. The deed transfers to the Yorba Linda Public Library all rights, title, and interest the donor may possess to the material. The deed provides space for a description of the donated material.

Generally, copyright belongs to the creator of writings and other original material (such as photos), but can be legally transferred to others. The Yorba Linda Public Library encourages donors to transfer any copyright they may control to the Yorba Linda Public Library whenever possible. Copyright ownership by the Yorba Linda Public Library facilitates use by researchers and the general public.

If you, as Donor, do not control copyright for the donated material, please initial the first box.

If you, as Donor, control copyright for the donated material, but do not wish to transfer the copyright to the Yorba Linda Public Library, please initial the second box.

If you, as Donor, control copyright for the donated material, and wish to transfer the copyright to the Yorba Linda Public Library, please initial the third box. Assignment of copyright may be conditional. For example, a Donor may wish to stipulate "Copyright retained during my lifetime" or something similar in the "Limitations" space provided on the Deed of Gift.

In certain circumstances, it may be possible for a donor to take a tax deduction for the donation of material. Donors are encouraged to speak with their tax accountants or attorneys about this possibility. The Yorba Linda Public Library cannot give tax advice or appraise the monetary value of material.

In order to make the most effective use of resources, the Yorba Linda Public Library reserves the right to determine the disposition of donated materials. This includes the right to reformat any material in its collection. For instance, donated items may be digitized for access via the World Wide Web or for other forms of electronic distribution.

Although most Donors will have no need to limit access to materials that they are donating, the option of placing reasonable restrictions on access to the materials or a portion of the materials is available to a Donor. A Library representative will be happy to discuss terms of restrictions with a Donor.
